Summary

This paper provides figures for the number of people claiming unemployment related benefits in the UK and by parliamentary constituency.


A full analysis of the latest UK labour market statistics is available in the Library briefing <u>UK labour market statistics</u>.

The unadjusted claimant count was **1.58 million** in May 2022, 19,700 less than the month before but 352,500 more than in March 2020.

Following the start of the pandemic, the claimant count more than doubled while the rise in unemployment was much smaller. This was partly due to changes in Universal Credit eligibility, and partly due to people being temporarily away from work or earning less because of the pandemic. Since the beginning of 2021, both measures have decreased, with the claimant count decreasing more rapidly than the unemployment rate. The unemployment rate is now back to pre-pandemic levels, while the claimant rate continues to be higher.

Unemployment and the claimant count saw similar trends until the coronavirus pandemic

The alternative claimant count models what the count would have been since 2013 if Universal Credit had always been in place, to adjust for the fact that more claimants are required to look for work under Universal Credit than under Jobseeker's Allowance.

The latest alternative claimant count data is for November 2021, when the seasonally adjusted alternative claimant count was **1.84 million**, 479,300 more than in March 2020.

Unadjusted claimant count and alternative claimant count

Unless otherwise stated, the claimant count figures provided in this paper are for the unadjusted claimant count. Figures for the alternative claimant count can be found in the accompanying excel file.

Figures for the unadjusted count are published every month, data for May 2022 were published on 14 June 2022.

Figures for the alternative count series are published each quarter and were last published in April 2022. They are next scheduled to be published in July 2022.

The data table starting on page 16 shows figures for the unadjusted claimant count. Further information about the claimant count is provided in Section 2 of this paper.

Unemployment and the claimant count

1 Labour market statistics

A full analysis of the latest UK labour market statistics, including the unemployment rate, is available in the Library briefing <u>UK labour market</u> statistics.

We have two sets of statistics for tracking unemployment:

Unemployment

includes everyone looking for and available for work.

The **claimant count**

includes people claiming benefits who are required to seek work

- The standard international measure of unemployment as defined by the International Labour Organisation includes everyone looking for and available for work (whether or not they are claiming benefits) and is measured using surveys. Small numbers of survey respondents at the local level mean estimates are volatile and not a reliable guide to trends.
- The number of people who are **claiming unemployment benefits**. This is measured by two series, both of which are available for local areas:

- The **unadjusted claimant count** is the number of people claiming Jobseeker's Allowance plus people claiming Universal Credit who are required to seek work. This series is timelier but is affected by changes to benefit rules, like the introduction of Universal Credit.

- The **alternative claimant count** models how many people would have been claiming these benefits had Universal Credit been fully in place since 2013. This series is likely to give a better indicator of trends after Universal Credit roll-out than the unadjusted figures. More detail is provided in Section 3.

The Library's briefing paper <u>Universal Credit and the claimant count</u> provides more information on why the rollout of Universal Credit has caused the claimant count to increase.

2 Claimant rates

The claimant rate shown in this paper shows the number of claimants as a proportion of the total resident population aged 16-64 in each constituency.

The rate used by the Library was amended in December 2019. Prior to this, the Library calculated its rate using the economically active population aged 16-64 in each constituency. More information on the reasons for this change is provided in section 4.3 of the Library briefing paper <u>Understanding statistics</u> on employment, unemployment, and earnings

The rates presented here should be regarded more as a social measure of relative deprivation than as an economic measure of the mismatch between the supply of and demand for labour, as they take no account of people's ability to seek work outside the constituency in which they live.

1.1Recent trends


Usually, trends in the number of people claiming unemployment benefits in the UK closely follow trends in unemployment.

From August 2016 the gradual rollout of Universal Credit meant more people were required to look for work to receive benefits (as discussed further in Section 3), and this led to the gradual increase in the claimant count shown in the chart below.

Following the start of the pandemic, the claimant count more than doubled while the rise in unemployment was much smaller. Since the beginning of 2021, both measures have decreased, with the claimant count decreasing more rapidly than the unemployment rate. The unemployment rate is now back to pre-pandemic levels, while the claimant rate continues to be higher.

Unemployment and the claimant count saw similar trends

This difference suggests that people who do not classify themselves as being unemployed may be claiming unemployment related benefits. This may be because:

- They have a job but were temporarily away from work due to the pandemic.
- They are in employment but are also able to claim unemployment benefits. People in employment can claim unemployment related benefits if their income is below a set threshold, and the job retention scheme and a reduction in working hours means this group has grown.
- They are temporarily inactive, and so are not actively looking for work.¹

In their July 2020 report <u>The truth will out</u> the Resolution Foundation estimated that **only around half** of the Claimant Count rise between March and May 2020 relates to those newly out of work. The report provides detailed analysis of why these figures are different and concludes that neither are accurate representations of current unemployment levels.² This means that claimant count figures, particularly during the coronavirus period, should be treated with caution.

Latest claimant count figures

The table below shows the latest unadjusted claimant count figures for the UK and how these have changed since March 2020. The latest unadjusted count figures are for March 2022.

The **seasonally adjusted claimant count** decreased by 56,900 across the UK between April and May 2022 to **1.58 million**. Since March 2020, before the coronavirus pandemic affected the UK labour market, the claimant count has increased by 352,500, and the largest increase was seen at the start of the first lockdown in March-May 2020, when it increased by 1.4 million.

As discussed in Section 1, part of the government's response to the coronavirus (COVID-19), a number of enhancements were introduced to Universal Credit. These may have increased the number of employed people eligible for Universal Credit through their earnings falling below income thresholds.³

Consequently, while some of the increase in the Claimant Count after March 2020 will be due to people who have become unemployed, some will also be due to employed people who have become eligible for Universal Credit as part of the government response.

The table in section 4 shows figures for each constituency on a non-seasonally adjusted basis, along with figures for countries and regions.

Adjusting for Universal Credit effects: an alternative claimant count series

As discussed in Section 1, under Universal Credit, a broader span of claimants is required to look for work than under Jobseeker's Allowance. This has the effect of increasing the number of unemployed claimants. As a result, the unadjusted claimant count is currently not a good indicator of longer term trends in the number of people who are looking for work.

In January 2019 the Department for Work and Pensions (DWP) started to publish the **'alternative' claimant count series**, <u>following a consultation</u> <u>exercise</u>. This models what the count would have been since 2013 if Universal Credit had always been in place. So, in addition to those currently claiming unemployment benefits, it also includes people who might not have been claiming at the time but who would have been required to look for work had Universal Credit been in place.

The chart below shows that the alternative claimant count was higher than the claimant count in January 2013, and the gap gradually closed as Universal Credit was rolled out.



Specifically, the alternative claimant count series includes:

People claiming Jobseeker's Allowance

- People claiming Universal Credit who are required to seek work, minus those awaiting a Work Capability Assessment (In the unadjusted claimant count series, Universal Credit claimants awaiting a Work Capability Assessment are included, although in practice these people will generally not be required to look for work).
- 'Additional' claimants who may not have been claiming unemployment benefits at the time, but who **would have been** required to seek work had Universal Credit been in place.

In Great Britain in February, there were (figures are seasonally adjusted):4

- 104,571 people claiming Jobseeker's Allowance.
- 1.57 million people in the UK claiming UC and were required to seek work (excluding those awaiting a Work Capability Assessment).
- 159,6522 additional claimants

The Library's briefing paper <u>Universal Credit and the claimant count</u> provides more information on why the rollout of Universal Credit has caused the claimant count to increase.

The following table provides this information for the alternative claimant count. The latest figures for this series are for February 2022 and are for the United Kingdom.



% of population aged 16-64 claiming unemployment related benefits, expressed as quintile groups (20% bands)






Edinburgh and Glasgow






Unadjusted claimant rate by constituency in May 2022




